LIABILITY INSURANCE REQUIREMENT:

All exhibitors are required to have liability insurance of no less than \$1,000,000 property damage, loss or theft and personal injury, naming Informa Connect, (parent company of TIDES 2024), Manchester Grand Hyatt, and GES as additionally insured, must be obtained by the exhibitor at his/her own expense.
